- I/we am/are at least 18 years of age and have a current, unrestricted driver's license(s) and am/are a driver in good standing with the state(s) of _______, which issued my/our license(s). I/we will not drive or take the Vehicle(s) outside of the United States or Canada.
- 2. All occupants of the Vehicle(s) will properly utilize all vehicle/occupant restraint systems, at all times during the operation of the Vehicle(s), including use of child protective restraints/seats (which are not provided by FCA).
- 3. I/we will operate the Vehicle(s) at all times in accordance with all applicable federal, state and municipal laws, regulations and ordinances, including use or non-use of cell phones, and will not operate the Vehicle(s) in a careless or reckless manner. I/we will not operate the Vehicle(s) while under the influence of alcohol, illegal or legal substances or drugs, illness or any other intoxicants or condition which could adversely impair my/our judgment or ability to safely operate the Vehicle(s).
- 4. I/we will not use a hand-held cell phone or engage in text messaging while driving the Vehicle(s); rather, I/we will only engage in hands-free cellular communications.
- 5. I/we will not permit any pets or animals in the Vehicle(s) at any time.
- 6. I/we will not use the Vehicle(s) for hire: (1) to transport people or property; (2) to be subleased; (3) for towing or plowing; or (4) in any competitive manner, on or off track.
- 7. Within the immediate past 24 months I/we have not: (1) been convicted of driving while intoxicated or under the influence (DUI/DWI); (2) had more than 1 at-fault accident; (3) been convicted of driving carelessly or recklessly, hit and run, road rage or vehicular homicide; or (4) had more than 2 moving violations on my/our driver's license(s).
- 8. I/we will not allow the Vehicle(s) to be driven by any individual other than a Vehicle Driver.
- 9. I/we am/are and will be responsible for any parking tickets, traffic violations or other costs associated with the operation of the Vehicle(s) while it is in my/our possession. In the event of an accident, damage or theft of the Vehicle(s), I/we will immediately notify the proper governmental authorities and, within 24 hours, complete the Vehicle Accident Report if it is provided in the glove box of the Vehicle(s).
